HOW TO REGISTER:

Course book and specific location information will be sent out approximately 2-3 weeks before the class starts.

COST:

SYSCO MN Customers:	\$145 per person
SYSCO Club Members:	\$135 per person
Non-Customers:	\$170 per person

This includes the course book and testing fee. Book is mailed 2-3 weeks prior to class. Late registrations (within one week) will receive book at class.

Payment must accompany registration if business is not a SYSCO customer or if customer has cash or COD terms. Course fee can be billed to active SYSCO customers. No refunds once book is mailed. 72 hour notice required for rescheduling. Rescheduling is subject to a \$30 fee. All no shows will be billed. Credit cards not accepted.

COURSE FORMAT: 8 Hour class plus exam (about one hour). Continental breakfast and lunch are included in course fee.

SCORING OF THE TEST: A score of 75% is needed to pass.

Tests are electronically scored and the results are received in approximately 2 weeks. A certificate of completion and the MDH application form is sent to each participant with the test scores. It is the responsibility of each person to apply for certification with the MN Dept. of Health as required by your health jurisdiction. State filing fee is \$28.
